### **Requirement of Completion:**

Students are required to successfully complete the didactic and laboratory of 364 hours, externship of 160 hours, Phlebotomy Technician 40 hours of practical clinical Laboratory setting. for a total clock hours of 604. Upon successful completion of the course with the appropriate number of hours required, in addition to a cumulative grade point of B (80%) in the midterm and final exam, and having fully paid all tuition charges, the student will be awarded the certificate of completion. This program will prepare you to take the Clinical Medical Assistant (CCMA), Medical Administrative Assistant (CMAA) examination through the National Healthcare Association (NHA) or exam (CMAA) through the National Healthcare Association (NHA) or California Certifying Board for Medical Assistants.
