Students are required to successfully complete the didactic and laboratory of 125 total clock hours. Upon successful completion of the course with the appropriate number of hours required, in addition to a cumulative grade point of B (80%) in the midterm and final exam, and having fully paid all tuition charges, the student will be awarded the certificate of completion.
