#### **Requirement of Completion:**

Students are required to successfully complete the didactic 60 hours and laboratory of 8 hours, clinical of 100 hours for a total clock hours of 160. Upon successful completion of the course with the appropriate number of hours required, in addition to a cumulative grade point of B (80%) and having fully paid all tuition charges, the student will be awarded the certificate of completion.
