Students are required to successfully complete the didactic and laboratory of 320 hours, externship of 160 hours, Phlebotomy Technician 80 hours of practical Clinical Laboratory settings, 40 hours externship for a total clock hours of 600. Upon successful completion of the course with the appropriate number of hours required, in addition to a cumulative grade point of B (80%) in the midterm and final exam, and having fully paid all tuition charges, the student will be awarded the certificate of completion.
